# 6 **Public Rights of Way:**

Cllr Huddleston has now made contact with the landowner regarding installation of 'kissing gates' on the footpath near Bainsbeck House. The landowner is agreeable to replacing the stiles with 'kissing gates' although this may involve taking out some of

the hedge and replanting. The Clerk will contact PROW with regard to the supply/installation of the gates using the ringfenced grant monies. Cllr Howarth expressed thanks to Cllr Huddleston and Mr Hayton for their efforts which are much appreciated.

### 7 Village pounds:

The rent for both of the village pounds has been received by the Clerk. The tenant has made a new gate for the smaller pound (Pound A) as the old gate is broken. As the pounds are 'listed' structures any replacement of the gateposts on the smaller pound should be a 'like for like' replacement (or repair) as can still be seen intact on the larger pound (Pound B).
