Minutes of the Parish Council Meeting held Monday 6 January 2025

Present: Cllrs David Howarth, Chris Preston, Helen Dinsdale, James Huddleston, Co Cllr Phillippa Williamson and the Clerk, Claire Helme.
One member of the public was present.

1 **Apologies:** None

2 **Declaration of conflicts of interest:** none declared.

3 **Minutes of the last meeting:**

Agenda Item 8, line 5 was amended from 'PACT' testing to 'PAT' testing.

Cllr Huddleston proposed acceptance of the minutes of 4 November 2024, this was seconded by Co Cllr Williamson and was signed as a true record by Cllr Howarth.

4 **Finance:**

a) Annual Budget Forecast

With receipts this financial year of £3,746 the balance carried forward at the end of March 2025 is estimated at approx. £6,087. The balance minus all unspent PROW grants is approx. £3,835. Spending this year has been similar to the previous year; unforeseen expenses included the cost of setting up a new website and .gov email address (£525 plus VAT). The forecast spend for 2025/26 is approx. £3,899 although the 3-year fixed term insurance ends in June and it is difficult to estimate by how much parish insurance might rise.

Precept

In order to keep pace with inflation and maintain healthy contingency reserves it was resolved that the 2025/26 precept increase by approx. 5% to **£3,900**. The tax base this year is slightly higher at 175.95 resulting in an amount of £22.16 per Band D household.

6 **Public Rights of Way:**

- The sign near Meadowlands that had broken off has been replaced and installed on the opposite side of the street.
- The broken sign at Snab Green Lane has not yet been replaced.
- The sign behind Cross House leading to the old station has been cleaned/tidied
- Any repairs needed on the Lune Valley Ramble are the responsibility of the Public Rights of Way department and are not within the scope of the grants awarded to the Parish Council.
- Cllr Huddleston has not yet made contact with the landowners regarding the potential for installing a 'kissing gate' next to Bainsbeck House.

7 **Village pounds:**

The rental agreement still needs to be sorted out with regard to Pound A and it was also noted that the pound gate was lying on the ground. With regard to Pound B the tenant reported difficulty in ridding the pound of ground elder in order to maximise its potential.

8 **Risk Assessment:**

- Electrical PAT testing on the pillar feed is complete but we have not yet received the results or the bill.
- Cllr Howarth will forward the written risk assessment of council assets that he recently completed to the Clerk.
